## ORDINANCE 89-12

AN ORDINANCE RELATING TO SPEED ZONES WHICH SPECIFICALLY DESIGNATES AREAS IN THE TOWN OF ANDERSON IN WHICH RATES OF SPEED SHALL BE TWENTY-FIVE (25) MILES PER HOUR ARE AUTHORIZED AND THE INSTALLATION OF TRAFFIC CONTROL DEVICES INCLUDING STOP SIGNS AND RELATED SPEED LIMIT SIGNS; RESCIDING ALL PARTS OF ORIDNANCE IN CONFLICT HEREWITH; AND DECLARING THAT ATTENDANT FACTS NECESSITATE IMMEDIATE ACTION.

## BE IT ORDAINED BY THE TOWN OF ANDERSON:

SECTION 1. That any and all ordinances or parts of ordinances relating to speed zones in areas identified in paragraph numbers 1-10 below are hereby rescinded, and the following areas are designated as areas in which a rate of speed of twenty-five (25) miles per hour is authorized. A map of the following areas is attached and incorporated within this ordinance. The speed limit in the following areas shall be twenty five (25) miles per hour. The Town of Anderson is hereby authorized to install a traffic control sign indicated the twenty-five mile per hour speed limit.

- 1. Entering Fanthorp St, south off FM 1774;
- 2. Entering Fanthorp St., north off FM 1774;
- 3. Entering North Johnson, off Hwy 90;
- 4. Entering Austin, south off Hwy 90;
- 5. Entering Austin, north off Hwy 90;
- 6. Entering Cedar Ln, south off FM 149;
- 7. Entering South Main, south off FM 1774;
- 8. Entering Hill St., south off FM 149;
- 9. Entering Hill St., north off Hwy 90; and
- 10. Entering Houston St., south off Hwy 90.

SECTION 2. The Town of Anderson is hereby authorized to install a stop sign for traffic control at the following two areas:

- 1. East side of Johnson St. at South Main: and
- 2. West side of Johnson at South Main.

SECTION 3. The enforcement of the speed limit and the stop signs is carried out by the Grimes County Sheriff's Department under an interlocal agreement and as authorized by the Texas Penal Code, the Texas Transportation Code and the Texas Code of Criminal Procedure.

SECTION 4. WHEREAS, the preservation of the general welfare of the public necessitates immediate action, this Ordinance shall be effective from and after the date of its passage as provided by the Charter of the Town of Anderson.
